The legislative session is off to a fast and furious start! I invite you to take a few minutes to read the latest news from the Government Relations Committee.

Simulation Day & Legislative Meetings in Albany During CRNA Week

We made our presence known in Albany during CRNA week. On January 23, we talked with lawmakers about the important role that CRNAs play in many areas, but with a specific highlight on the maternity/obstetric area. As we noted last month, for those that are unaware, there have been several recent announcements about the closure of birthing centers around the State, and these closure are related to a lack of providers. We highlighted how recognizing CRNAs is one of the most important ways to help address the worker shortage and <u>left this flyer with every legislative office</u>.

While we were in Albany, we also had a number of key legislative meetings, including with the chairs of the Assembly and Senate Higher Education Committees. We continued to discuss our scope of practice bill with them and continued to talk next steps and made clear that our goal is to get our bill passed this session. We will continue to talk with the chairs and leadership in both houses. We also talked with our bill sponsors while we were in town and thanked them once again for their leadership and dedication to our issues.

State Education Department Technical Review

Our conversations continue with the State Education Department. We had a very productive meeting in January to discuss some further technical changes needed to our scope bill. We have made some additional changes to reflect their feedback and will wait to hear back from them. We were pleased with overall feedback and believe we are close to having final technical sign off on our legislation, which is important for final passage of our legislation.
